A course map can be found at www.bienifunrun.org. This 5K (3.1 mile) cross country course winds through the HPA campus and includes a challenging hill along with downhills and flats. Two aid stations will be available along the course.

Agreement for Assumption of Risk, Waiver of Claims, and Indemnification Arising Out of the Use of Hawai'i Preparatory Academy (HPA) Facilities

FOR AND IN CONSIDERATION OF the opportunity to use HPA facilities, including but not limited to your presence as a participant, spectator, guest, or visitor during the Bieni Kohler Johnson 5K Fun Run/Walk on September 4, 2011, you agree to the following:

- (1) In recognition that the facilities and activities may involve some inherent risk that cannot be totally eliminated, Undersigned assumes all risk, known and unknown, of injury to person, including death, and damage to property resulting from Undersigned's use of the facilities.
- (2) Undersigned expressly agrees to waive all claims and rights of subrogation and release, indemnify, defend and forever hold harmless HPA from any loss, liability, joint liability, several liability resulting from any and all claims, demands, or actions against HPA by Undersigned or any person or entity holding by or through Undersigned or any insurance carrier or organization or person for payment or reimbursement of any debts, obligations, liens, joint tort feisor claims, or claims for contribution or indemnity relating in any way to the matters covered by this Agreement.
- (3) The terms of this Agreement shall be enforceable to the greatest extent allowed by law with respect to Undersigned and HPA, each of which is defined to include its respective parents, guardians, heirs, executors, administrators, representatives, successors, assigns, trustees, receivers, agents, employees, officers, directors, stockholders, general or limited partners, joint ventures, parent or subsidiary corporations, related or affiliate entities, and all persons, entities, or parties claiming by, through, or under the named parties.
- (4) Undersigned agrees to provide HPA with a properly signed and dated copy of this Agreement before entering or using any facility, and to provide, upon request, proof of identification that includes a recent photograph.
- (5) Undersigned will not, absent written permission by HPA, participate in activities or be physically present on the HPA site, structures, or equipment, except when appropriately supervised by HPA or authorized licensee.
- (6) Undersigned agrees to comply with all applicable requirements, rules, and regulations of government entities, authorized licensees, and HPA while using any facility.
